Frequently asked question regarding for COVID-19 and Camp Jaycee

Q: Who is guiding Camp Jaycee's health and safety plans?

A: Camp Jaycee is guided by federal, state, and local health offices and working in regular consultation with our partners at the American Camp Association, The Arc of New Jersey, and our Board of Directors to ensure we have effective protocols in place to safely run our summer camp program.

Q: Is there a vaccination Policy?

A: Yes, all campers must be up to date on the COVID-19 vaccination as defined by the CDC, 14 days prior to their arrival at camp.

Q: What if I am already registered, I am not vaccinated and do not plan to be vaccinated?

A: Please contact <u>mbrennan@campjaycee.org</u> to withdraw your registration. You will be provided a full refund if camp is notified by February 18, 2022.

Q: How will Camp Jaycee prove my camper is vaccinated?

A: All campers must upload a copy of their COVID-19 Vaccination card. If they are uncomfortable doing that, they may request a waiver and have their doctor sign a confirmation of their vaccination.

Q: What if I have a medical or religious exemption from the COVID-19 vaccination?

A: Camp Jaycee requires all campers and staff to be up to date on their COVID-19 vaccination.

Q: Will Camp Jaycee require my camper to have a negative COVID-19 test prior to arriving at camp?

A: It is very likely that Camp Jaycee will require a negative COVID-19 test 72 hours prior to camper arrival. Camp Jaycee will decide on this procedure by May 1, 2022.

Q: Will I get a refund (if DDD pays for my camper will I be liable) if my camper is unable to attend camp due to COVID-19?

A: We would honor a full refund less the \$150 application fee with proof of that positive test. Families can also rollover that tuition to a later session of camp if there are available weeks in the Summer 2022. Any other cancellations will be at the discretion of the Camp Jaycee administration.

Q: What if someone on camp tests positive for COVID-19?

A: Camp Jaycee staff will follow their communicable disease action plan. This will be available prior to the camp as we monitor the most recent suggestions and guidelines.

Camp Jaycee will release protocols for camper check in/check out, an outline of camp operation procedures and additional COVID-19 information no later than May 1, 2022.
